



## Image and Information Release Agreement for Adult Scholarship Recipient

In consideration of potential publicity as indicated herein, and to advance the charitable and educational mission of PPEF, the undersigned makes the following representations and agreements for the benefit of PPEF, its licensees, designees, and successors and assigns (collectively "PPEF").

**Authorization.** I represent that I have the right and authorization to enter into this Agreement.

**Image Provided.** I provided a color photograph (either a print or a digital file) of myself (the "Image") for PPEF's benefit, use and publication in relation to PPEF's charitable and educational mission, programs and other lawful uses.

**License; Warranty of Right to License.** I hereby grant to PPEF the perpetual, worldwide right and license to use the Image and my name, likeness, and appearance for any purpose related to PPEF and for any other lawful purposes, including broadcast, brochure, web and any other media (digital or otherwise). If the Image contains pictorial products that are subject to trademark, copyright or other intellectual property protection ("Protected Material"), I warrant and represent that I have permission from the owner of such Protected Material to grant these rights of use and the license to PPEF.

**Right to Edit.** I irrevocably authorize PPEF the right to edit, alter, copy, exhibit, publish and distribute photo and videos containing the Image or my likeness for any purpose related to PPEF. I waive the right to inspect or approve the finished product wherein the Image or my likeness appears.

**No Compensation.** I waive any right to royalties or other compensation related to the use of the Image or my name or likeness.

**Application Information.** I also grant PPEF the right to use and publish, in any manner and through any medium (via the internet or otherwise), information contained in the scholarship application I submitted to PPEF.

**Indemnification.** I AGREE TO INDEMNIFY AND HOLD HARMLESS, PPEF, ITS LICENSEES, DESIGNEES, SUCCESSORS AND ASSIGNS, AND THEIR RESPECTIVE AGENTS AND REPRESENTATIVES, FROM AND AGAINST ANY AND ALL CLAIMS ARISING OUT OF THE ABOVE-GRANTED LICENSE AND REPRESENTATIONS, INCLUDING ALL CLAIMS, DEMANDS AND CAUSES OF ACTION THAT I, MY HEIRS, REPRESENTATIVES, EXECUTORS, AND/OR ADMINISTRATORS HAVE OR MAY HAVE DUE TO THIS AGREEMENT, MY REPRESENTATIONS, AND/OR THE RIGHTS GRANTED HEREIN.
